## Rural Municipality of Cartier By-Law No. 1678-20 Zoning By-Law Amendment

Being a By-law of the Rural Municipality of Cartier to amend the Rural Municipality of Cartier Zoning By-Law No. 1658-18.

WHEREAS The Planning Act provides that a Zoning By-law may be amended;

**AND WHEREAS** it is deemed necessary and expedient to amend the RURAL MUNICIPALITY OF CARTIER ZONING BY-LAW NO. 1658-18.

**NOW THEREFORE**, the Council of the Rural Municipality of Cartier, in meeting duly assembled, enacts as follows:

- 1.0 That PART III ZONING DISTRICTS Section 15.4 9) is changed to read:
  - 9) Apiaries
    - a) No person shall establish an apiary on a site without first obtaining a development permit from the Designated Employee or Officer,
    - b) Hives are limited to a maximum of four (4) per site and must be:
      - i) Set back at least 25 feet (7.5 metres) from any site line; and
      - ii) Concealed behind a solid fence 6 feet (1.8 metres) in height.
    - c) All landowners keeping bees must ensure hives are properly maintained. Bees must be re-queened if they swarm or show aggressive behavior
    - d) Must adhere to all provincial licensing requirements
- 2.0 That Appendix B Permitted and Conditional Use Table, is changed to add apiaries as a Conditional Use in the following zone:

RR2 (Rural Residential) Zone (refer to attached Appendix B).
